PRIVACY POLICY

This Privacy Policy (“Policy”) is provided by Deer Park Road Management Company, LP (collectively with the funds and accounts sponsored or managed by it, “Company,” “we,” “us,” or “our”). It describes how the Company collects and processes personal information about individuals other than those who use our services for their personal, household, or familial investment or money management purposes or who inquire about our products or services in that regard (collectively, “customers”). We have a separate privacy notice we provide to our customers.

Notice at Collection: Personal Information We Collect

We collect the following categories of personal information:

- **Contact information and other identifiers:** Name, contact information, IP address, device IDs and other similar identifiers
- **Commercial and financial information:** Prospective investors’ financial information
- **Internet and other electronic activity information:** Device and browser type, browsing and search history on our websites, and information regarding interaction with our websites
- **Professional information:** Information about your employer or other entities or individuals you represent, job titles and positions

We have collected the same categories of personal information in the 12 months prior to the date of this Policy.

Notice at Collection: Purposes for Collection of Personal Information

We collect personal information above for the following purposes:

- Operating and managing our websites
- Researching potential new clients
- Operating and managing our business and properties
- To prevent fraud and for IT security purposes
- Enforcing or defending our rights

Notice at Collection: No Sale or Sharing of Personal Information for Behavioral Advertising

We do not sell personal information and do not share personal information for purposes of cross-context behavioral advertising.

Notice at Collection: Retention Periods

We retain the categories of personal information we collect for the length of time necessary to provide our services and to comply with legal obligations or to protect our legal rights.

Sources From Which We Collect Personal Information

We collect personal information from: individuals who interact with our websites or attend events we sponsor, host, or promote; individuals who interact with us in the course of providing services or products to us; referral sources; research services; and publicly-available sources.

No Use or Disclosure of Sensitive Personal Information

We do not use or disclose sensitive personal information for purposes of inferring characteristics about a consumer or for any other purposes other than as necessary to operate our business.

Disclosure of Personal Information For Business Purposes in the Past 12 Months

We disclosed the following categories of personal information for a business purpose in the 12 months prior to the date of this Privacy Policy:

Business Purposes for Disclosures of Personal Information

We disclose personal information to vendors that work with us to operate our business, including management of our websites, data security services, fraud detection and security-related functions, cloud-based data storage, assistance with other IT-related functions, market our business, provide analytics information, provide legal and accounting services, and host conferencing services.

Additional Information About How We May Disclosure Personal Information

We may also disclose your personal information as required or permitted by law to comply with a subpoena or similar legal process or government request, or when we believe in good faith that

disclosure is legally required or otherwise necessary to protect our rights and property or the rights, property or safety of others, including to law enforcement agencies, and judicial and regulatory authorities. We may also disclose your personal information to third parties to help detect and protect against fraud or data security vulnerabilities. And we may disclose or transfer your personal information to a third party in the event of an actual or potential sale, merger, reorganization of our entity or other restructuring.

Our Use of Cookies and Analytics

We may use cookies, pixel tags, web beacons and other similar tracking technologies (“tracking technologies”) to automatically collect information through our Sites. Tracking technologies are essentially small data files placed on your computer, tablet, mobile phone, or other devices that record certain pieces of information when you visit our Sites. We may use these tracking technologies to help identify irregular behavior, prevent fraudulent activity and improve security, as well as making it possible for you to save your preferences and help us understand how you interact with our Sites.

You may set your browser to notify you when you receive a cookie. Many web browsers also allow you to block cookies. You can disable cookies from your computer system by following the instructions on your browser or at www.youradchoices.com.

We use Google Analytics to evaluate the use of our Sites. Google Analytics uses cookies and other identifiers to collect information, such as how often users visit our Sites, what pages they visit when they do so, and what other websites they visited prior to visiting our Site. Personal Information of Minors

Our Sites are not directed to persons under age 13 and we do not knowingly sell or share for purposes of behavioral advertising the personal information of minors, including minors under the age of 16.

Do Not Track Signals

At this time, our Sites do not respond to do not track signals.

Security Measures

We implement and maintain reasonable security measures appropriate to the nature of the personal information we collect, use, retain, transfer or otherwise process. While we take such measures to safeguard your personal information, we cannot guarantee the absolute security of our Sites and services. Accordingly, it cannot be assumed that the occurrence of any given incident or breach results from our failure to implement and maintain reasonable security measures.

Third-Party Links

Our websites may contain links to websites operated by third parties over which we have no control. Should you click on a link to a third-party website, the privacy policy of that website will apply instead of our Privacy Policy. We are not responsible for the content or security of third-party websites.

Changes to this Privacy Policy

We will review and update this Policy periodically. We will notify you of material changes to the Policy through our website.

Rights of California Residents Regarding Personal Information

If you are a California resident, you may have certain rights described in this section of our Policy, including rights covered by the California Consumer Privacy Act (the “CCPA”).

Please note that rights under the CCPA do not apply to information about Company investors that is covered by the Gramm-Leach-Bliley Act and implementing regulations, and the California Financial Information Privacy Act, laws which generally apply to nonpublic personal information about individuals who obtain financial funds or services from us primarily for personal, family, or household purposes.

Right To Know About Personal Information We Collect

You may submit a request to us for any or all of the following types of information about the personal information we have collected about you in the 12 months prior to our receipt of your request:

- Specific pieces of personal information we have collected about you;
- Categories of personal information we have collected about you;
- Categories of sources from which such personal information was collected;
- Categories of personal information we sold or disclosed for a business purpose about you;
- Categories of third parties to whom the personal information was sold or disclosed for a business purpose; and/or
- The business or commercial purpose for collecting or selling your personal information.

Right To Request Deletion of Personal Information We Have Collected From You

Upon your request and subject to exceptions in the law, we will delete the personal information we have collected from you.

Your Right to Request to Correct Personal Information We Hold About You

You have the right to request that we correct personal information we hold that you believe is not accurate. We will take steps to determine the accuracy of the personal information that is the subject of your request to correct, and in doing so will consider the totality of the circumstances relating to the personal information you have identified as being incorrect. We may ask that you provide documentation regarding your request to correct in order to assist us in evaluating the request.

California Shine the Light

California Civil Code Section 1798.83, also known as the “Shine the Light” law, permits California residents to annually request, free of charge, information about certain categories of personal information a business has disclosed to third parties for direct marketing purposes in the preceding calendar year. We do not share personal information of California residents with third parties for their own marketing purposes.

Our Commitment to Honoring Your Rights

If you exercise any of the rights explained in this Policy, we will continue to treat you fairly. If you exercise your rights under this Policy, you will not be denied or charged different prices or rates for goods or services or provided a different level or quality of goods or services than others.

Exercising Your Rights and How We Will Respond

Verification of Identity – Requests to Know, Delete or Correct

When you submit a CCPA request, we will ask you for two pieces of personal information and attempt to match it to information that we maintain about you in order to verify your identity.

If we are unable to verify your identity with the degree of certainty required, we will not be able to respond to the request. We will notify you to explain the basis of the denial.

Authorized Agents

You may designate an agent to submit requests on your behalf. The agent can be a natural person or a business entity.

If you would like to designate an agent to act on your behalf, you and the agent will need to comply with our agent verification process. If the agent submits a request, the agent will need to provide us with your signed permission indicating the agent has been authorized to submit the request on

your behalf. We will also require that you verify your identity directly with us or confirm with us that you provided the agent with permission to submit the request.

Please note that this subsection does not apply when an agent is authorized to act on your behalf pursuant to a valid power of attorney. Any such requests will be processed in accordance with California law pertaining to powers of attorney.
